
Dear Professor Kronstein:

Dear Colonel Boyd:

I should like to take the liberty of giving you this personal note of introduction on behalf of Dr. Heinrich Kronstein, who I understand is being assigned to your staff.

Dr. Kronstein has had a long acquaintance with this Government's policy towards problems of German industrial organization, and on many occasions has had an active role in the preparation of such policy. Since 1940, he has been associated with the Dept. of Justice in the Anti-Trust Div., and has been Chief Advisor to that Department on questions of International Cartel relationships and foreign law. He has a considerable knowledge of cartel agreements between German nationals and nationals of the United States, Great Britain, France, Belgium, Holland and Switzerland. For some time, he has been a personal advisor to Secretary Wallace on matters pertaining to combines, trusts, and private industrial agreements.
